- During the winter season, parked cars must be moved to facilitate snow plowing

Homeowner Lawn Maintenance

- Weeding, edging and weed whacking are homeowners responsibilities
- Homeowners on corner lots are responsible for boulevard maintenance as well

Homeowner Snow Removal

- Don't plow snow out into the street. This is illegal and subject to fines
- Sidewalks need to shoveled with 24 hours of a snowfall

Invisible Fence Installations

- Make sure you are not infringing on your neighbor's property or the commons area

Frequent and/or Habitual Barking Dogs

- Violation of Township Nuisances Ordinance 53-7
- Pets Must be Leashed and Curbed

Vehicular Parking and Storage

 No trailer, mobile home, bus, boat trailer, boat, camping vehicle, motorcycle, recreational vehicle, commercial or inoperative vehicle of any description shall at any time be parked, stored or maintained on any Lot, unless stored fully enclosed within an attached garage.

Trash Pick-Up

- No trash may be placed curbside any earlier than 4:00pm on Tuesday

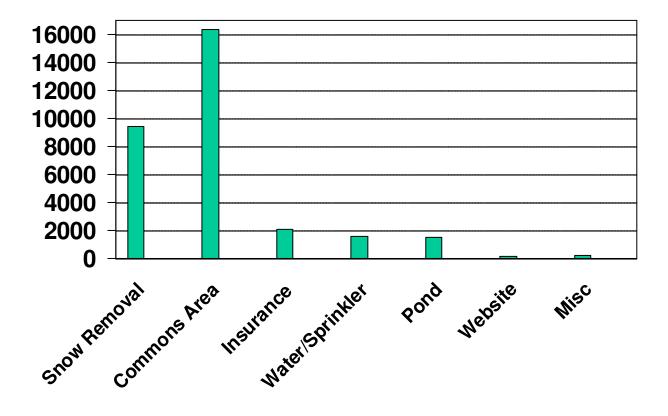
