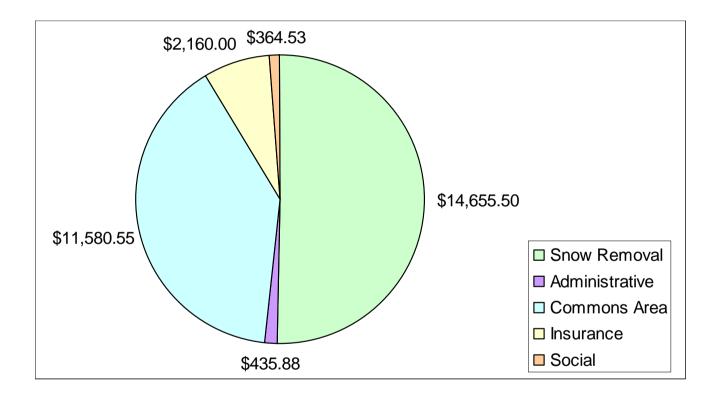

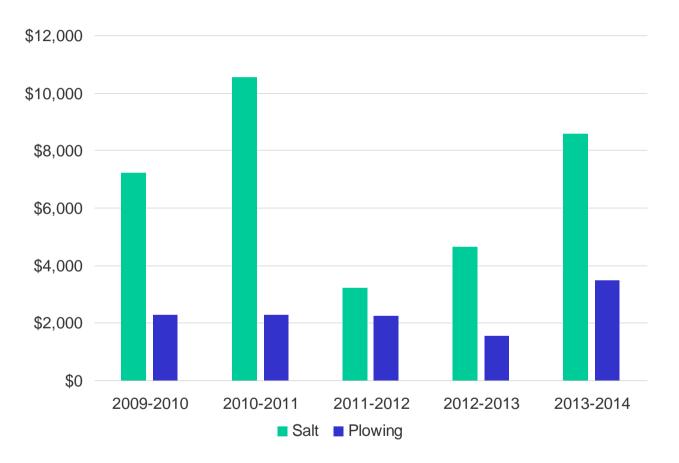
2014 Major Item Expenditures
